

COVID – 19 WAIVER

While it is not possible to eliminate all risk of furthering the spread of COVID-19, Hanover Youth Wrestling will take necessary precautions and comply with guidelines from the federal, state, local governments and CDC to reduce the risks to wrestlers and coaches. As knowledge regarding COVID-19 is constantly changing, Hanover Youth Wrestling reserves the right to adjust and implement precautionary methods as necessary to decrease the risk of exposure for our wrestlers and coaches. Some precautionary methods include, but may not be limited to:

1. Health screenings prior to any team meeting, practice, or event. This includes taking wrestler's temperature and checking list of symptoms.
2. Encourage social distancing if possible and promote healthy hygiene practices such as hand washing, using hand sanitizer, etc.
3. Intensify cleaning, disinfection of practice facilities.
4. Require players, cheerleaders, coaches, and officials to provide their own water bottles for hydration.
5. Parents must take wrestler's temperature prior to practice. Anyone who is sick must stay home, including a fever of 100.4 degrees or above.
- 6. PARENTS WILL NOTIFY COACH ANDY BECKNER IMMEDIATELY IF WRESTLER OR ANY FAMILY MEMBER ARE IN CONTACT WITH ANYONE WHO IS BEING TESTED OR WHO HAS TESTED POSITIVE FOR COVID-19.**

In consideration of the above requirements, I, on behalf of the player or cheerleader, and I, the player or cheerleader, acknowledge the following:

- Participating in the upcoming season may include a possible exposure to a communicable disease, including but not limited to MRSA, influenza, and COVID-19. I (WRESTLER/PARENT) must be an active participant in my/his/her own healthcare.
- In consideration of my/his/her voluntary involvement, I have had an opportunity to carefully read the current CDC Guidelines for COVID-19 virus related health risks and understand the recommended precautions, along with the above requirements.
- I voluntarily and willingly choose to have a wrestler participate in the upcoming season. I willingly agree to comply with all procedures, protocols, and requirements put into place by Hanover Youth Wrestling in order to provide for safe athletic participation, to keep myself and others safe, and to limit and reduce the exposure to and spread of COVID-19 and other communicable diseases.

- I knowingly and voluntarily assume all risks related to the COVID-19 virus. I acknowledge that while particular recommendations and personal discipline may reduce the risk, the risk of serious illness and death does exist and I assume full responsibility for my/his/her participation.

*Parents/guardians, wrestlers are expected to abide by all guidelines for participation. The guidelines were developed to protect the health and safety of all involved. Due to the seriousness of COVID-19 violators will be suspended from participating in the upcoming season.
